Taoiseach to avoid Fianna Fáil heave in short term

There is little appetite in parliamentary party for an immediate move to oust him

Martin will continue to meet TDs in a bid to heal relations after presidential fiasco

There is little apparent appetite among Fianna Fáil TDs for an immediate heave against party leader Micheál Martin, a survey of the party's Dáil deputies suggests.

But Fianna Fáil's disastrous presidential election campaign may still threaten Mr Martin, with many TDs declining to say if they back the Taoihis 15th year as party leader.

dential campaign. Wicklow-Wexford TD Malcolm Byrne, who will be meeting Mr Martin today, said that the Taoiseach had "led Fianna Fáil through some very difficult periods ... The presidential election campaign, though, was a disaster and has left many members and supporters angered and disap-

pointed" On Saturday, Dublin South-West TD John Lahart said that while Mr Martin enjoyed "significant respect" and "great affection" within the party, the Taoiseach had made "significant errors in judgment in the run-up to and during the presidential election campaign".

In response to Mr Lahart's remarks, Minister of State Thomas Byrne appealed for unity. "The one thing I would say is ... we really need to come

together as a party," he said. The Irish Times contacted each of Fianna Fáil's 48 TDs yesterday, and asked them if they would support a motion of no-confidence in Mr Martin's leadership, if they wanted him to step down before the Republic takes on the presidency of the Council of the European Union in July, and if they believed Mr Martin

should step down after the EU presidency term ends?

The majority declined to respond. All TDs and Ministers happy to be quoted on the record were supportive of Mr Martin's leadership. They included Minister of State Timmy Dooley, who answered each question "no, no and no". Chief Whip Mary Butler said that she "absolutely supports' the Taoiseach to lead the country and the Government seach as he prepares to enter through the EU presidency and after. Minister for Transport Darragh O'Brien said he had "full confidence in Micheál Martin. He should lead us into the next election wake of the embarrassing exit and he will". "I think from the point of view of not getting a nomination, you'd have to ask yourself, why was there such a determined effort to stop me from getting a nomination? Maybe because I would win it, and that's the way I would have been approaching it."

State steps up efforts to deport convicted criminals

Efforts to deport convicted criminals from the Republic have been stepped up in recent months, with a record number of those in Irish prisons now also having exclusion orders imposed.

The orders mean criminals can be deported to their European Union country of origin and are then banned from returning to the Republic for up to 10 years.

Children's hospital legal costs soar in €880m battle

Expenditure by the board of the new National Children's Hospital on legal fees, litigation and defending claims rose from €2 million in 2023 to more than €6 million in 2024.

The rise in costs was driven by proceedings taken by construction company BAM against the hospital board under its contract. The board is now defending claims in excess of €880 million from BAM, it said last night.

The hospital is set to be the most expensive health infrastructure project in the State, with a final cost of at least €2.4 billion.

It has run over multiple budgets and deadlines, and there are fears it will not meet its July 2026 opening date - the 16th time since 2020 that its

completion has been pushed more than €1.6 million in 2024.

Relations between the National Paediatric Hospital Development Board (NPHDB) and BAM have publicly deteriorated in recent years.

The hospital's builders have claimed that design changes have affected their ability to finish the project, while the board has said that many parts of the hospital that BAM presented as completed still had snags.

High Court

The NPHDB financial statements for 2024, which were laid before the Oireachtas last week, said by the end of April this year, the amount the board spent on professional fees for "litigation and claims defence" rose from €1.8 million in 2023 to €4.4 million in 2024.

Fees for "legal expenses" also rose from €224,000 in 2023 to

BAM has initiated several legal proceedings against the board, and the 2024 accounts show four cases in which court proceedings initiated by the construction company resulted in the NPHDB being required, under its contract, to pay more than €160 million in a bond to BAM. This was funded directly from the HSE and paid to the

company by the board. A spokeswoman for the board said it is "actively defending claims in excess of €880 million from BAM, including the duplication and triplication of claims".

She said there were claims "at all levels of the dispute mechanism process" up to and including the High Court, with costs also incurred for adjudication and conciliation.

BAM did not respond to requests for comment.
