Knesset advances political Oct. 7 probe as bereaved parents protest

Parents whose sons were killed on October 7 speak against proposed bill, to no avail

The Knesset on Wednesday approved, in a preliminary vote, a bill backed by the government to establish a commission of inquiry into the October 7 massacre that would be controlled by politicians.

During the Knesset debate, bereaved parents watched from the visitors' gallery and shouted "shame" and "those under

All opposition lawmakers arrived dressed in black, and several were removed from the chamber after shouting or holding up signs. During the vote, members of Yesh Atid and Ra'am party leader Mansour Abbas tore up copies of the bill.

"To ensure that such a disaster never happens again, all state systems must be examined," said the bill's sponsor, Likud MK Ariel Kallner,

Israel, Hamas trade accusations over Gaza explosion

Khoury and Reuters Israel and Hamas traded

accusations over an explosion that injured a soldier in Gaza on Wednesday.

According to an Israel Defense Forces spokesperson, an improvised explosive device was detonated on an armored vehicle, slightly wounding a combat officer, during operational activity in the Rafah area "aimed at dismantling terrorist infrastructure.'

Hamas official Mahmoud Mardawi said the explosion was caused by bombs left behind by Israel. According to him, Hamas reported the incident to mediators.

The Prime Minister's Office released a statement condemning Hamas for ongoing violations of the cease-fire and President Trump's 20-point plan.

"Their ongoing and continuing public refusal to disarm is an ongoing flagrant violation," it added. "Again today, their violent intentions and violations were confirmed by their detonation of an IED that wounded an IDF officer.'

Budget for crimefighting in Arab society underused

The National Security Ministry, headed by Itamar Ben-Gvir, used only half of the funds allocated in the 2022-2026 five-year budget to fight crime and violence in the Arab community, official ministry data shows.

The data, obtained through a Freedom of Information request filed by the Movement for Freedom of Information, indicates that out of the National Security Ministry's 1.5-billion shekels (around \$405 million) under the five-year bud-

get, only 748 million shekels (around \$202 million) have been utilized. Half the budget was spent over four years, with the remaining half available for use in the final year of the plan.

According to ministry data, several key programs in the five-year plan have yet to be implemented, despite having been budgeted. One such program is "Stop the Bleeding," which was initiated by the American Joint Distribution Committee, or the JDC, and operated in seven Arab towns through

Tracking shows 'urban' jackals thriving on abundant food in TA

Jackals have made Tel Aviv their permanent home thanks to a steady supply of food and ample shelter, according to findings presented Tuesday at the Jackals in the Urban Space conference organized by the Tel Aviv-Jaffa Municipality.

Estimates indicate that several hundred jackals now live within the city limits, roaming all areas - from the northern neighborhoods to Jaffa and even the city center. In most cases, the jackals enter residential neighborhoods to search for food and then return to open spaces, primarily around the Yarkon River.

Municipal monitoring of the jackal population,

vealed that some jackals travel no more than 200 meters in a 24-hour period. These animals mainly roam the area between the Yarkon River and the site of the former Sde Dov airport. Jackals in the wild typically cover an average distance of more than two kilometers a day The limited movement of these urban jackals suggests that they have learned to depend on the readily available food and shelter in the

Acclaimed actor and director Mohammad Bakri dies at 72

Actor and director Mohammad Bakri died on Wednesday at the age of 72 after suffering from heart and respiratory problems. His health deteriorated suddenly in recent days, and he was hospitalized a few days ago. He is survived by a daughter and five sons.

Bakri gained widespread recognition for his

performances in films such by Israel Defense Forces as "Beyond the Walls," (1984) "Fellow Travelers" (1983), "Cup Final" (1991) and "Desperado Square" (2001), as well as for numerous roles on stage. In 2002, he directed the documentary "Jenin, Jenin," which presented conversations with residents of the Jenin refugee camp and their testimonies regarding war crimes they
